RESIDENTS You may be aware that the current owners of

Great Chishill Windmill, Cambridgeshire County Council, wish to dispose of the building as it has become surplus to their requirements. Over the years, their track record on maintenance has been less than satisfactory to the point that recently frequent emergency repairs have been required.

Apart from this Grade 2*Listed Building being of significant historic interest, the Parish Council holds the opinion that the Windmill is both an important landmark and an 'identifier' for the village as well as an object of positive sentiments for the residents of the Chishills. If this is the case, the Parish Council will explore a number of options, with the longterm aim of securing the future of the Windmill under an acceptable set of financial and management arrangements. These options could include.

*Acquiring the Mill for a nominal fee and then leasing it to a specialist organisation



on a 99 year, full repairing lease

*Acquiring the Mill for the Parish to hold in trust and to renovate by obtaining grants from such organisations as, for example, English Heritage or the Heritage Lottery Fund

So that we do not act on false assumptions, the Parish Council would like to gather your thoughts and opinions. To this end, residents are to be sent a letter with a ballot slip attached. Please fill it out and post it in the green box on the side of the bus shelter by the end of February.

A505 Flint Cross speed limit review for a reduction in speed limit to 50MPH: There were no objections in the public consultation (which I have to say was quite limited) but therefore it has gone ahead swiftly.

Addenbrooke's Access Road:

The Highways Cabinet member has now formally declined the suggestion of adding volunteer drivers from established community transport schemes to the Addenbrooke's Road White List, having taken his officer's advice that this is unnecessary. Melbourn Library Access Point has added Tuesdays, 2:30-4:30, to its opening times. Library Access Points figure in the massive Library budget cuts and Melbourn Library, ironically, is growing in terms of volunteer staff and usage.
